#### 1. Presentation of the site.

### 2. General conditions of use of the site and the services offered.

Use of the awishforhumanity.org site implies full acceptance of the general conditions of use described below. These conditions of use may be modified or supplemented at any time, users of the <u>awishforhumanity.org</u> site are therefore invited to consult them on a regular basis.

This site is normally accessible to users at any time. An interruption due to technical maintenance may however be decided by A WISH FOR HUMANITY, which will then endeavor to communicate to users before the dates and times of the intervention. The awishforhumanity.org site is updated regularly by Lisbeth Monéton. In the same way, the legal notices can be modified at any time: they nevertheless impose themselves on the user who is invited to refer to them as often as possible in order to become acquainted with them.

### 3. Description of services provided.

# 7. Management of personal data.

In France, personal data is notably protected by law n° 78-87 of January 6, 1978, law n° 2004-801 of August 6, 2004, article L. 226-13 of the Penal Code and the European Directive of October 24, 1995.

When using the awishforhumanity.org site, the following may be collected: the URL of the links through which the user accessed the <u>awishforhumanity.org</u> site, the user's access provider, the Internet Protocol (IP) address of the user.

In any case A WISH FOR HUMANITY only collects personal information relating to the user for the need of certain services offered by the site awishforhumanity.org. The user provides this information with full knowledge of the facts, in particular when he enters it himself. It is then specified to the user of the site awishforhumanity.org the obligation or not to provide this information.

In accordance with the provisions of articles 38 and following of law 78-17 of January 6, 1978 relating to data processing, files and freedoms, all users have a right of access, rectification and opposition to personal data. concerning him, by making his written and signed request, accompanied by a copy of the identity document with signature of the holder of the document, specifying the address to which the answer must be sent. No personal information of the user of the awishforhumanity.org site is published without the knowledge of the user, exchanged, transferred, assigned or sold on any medium whatsoever to third parties. # 8. Hypertext links and cookies.

A cookie is a small file, which does not allow the identification of the user, but which records information relating to the navigation of a computer on a site. The data thus obtained are intended to facilitate subsequent navigation on the site, and are also intended to allow various measures of attendance.

Refusal to install a cookie may make it impossible to access certain services. However, the user can configure his computer to refuse the installation of cookies.

# 9. Governing Law and Jurisdiction.
